## AMENDMENT TO THE DECLARATION OF Reach, Florida 33480

COVENANTS AND CONDITIONS OF INDIAN CREEK PHASE V

RECORDED IN OFFICIAL RECORD BOOK 4061, PAGE 278, OF THE PUBLIC

RECORDS OF PALM BEACH COUNTY, FLORIDA.

WHEREAS, at the duly called meeting of INDIAN CREEK PHASE V HOMEOWNERS ASSOCIATION, INC., and the lot Owners of INDIAN CREEK PHASE V held on May 23, 1985, for the purpose of Amending the above described Declaration of Covenants and Restrictions, by adding new subparagraphs (c), (c)(i), (c)(ii) and (d) to Section 1. of ARTICLE VI, and, more than 75% of the membership approved the amendement as set forth below, and

Amendment (and they constitute the ownership of more than 75% percent of the total 52 lots) and they hereby Amend said ARTICLE VI as follows:

ARTICLE VI MISCELLANEOUS PROVISIONS

Section 1. Enforcement

"(c) To require any owner who leases an improved lot in Page V to execute an addendum to the lease together with the tenant thereof to provide:

(i) The tenant's agreement to abide by the provisions of the Declaration of Covenants and Conditions, the Subdivision Restrictions covering Indian Creek V, recorded in Official Record Book 4061, page 287, the Articles of Incorporation, and By-Laws thereto of Indian Creek Phase V Homeowners Association, Inc. recorded in Official Record Book 4061 at pages 297 and 304, respectively, all in the Public Records of Palm Beach County, Florida, as amended from time to time and the Rules and Regulations of the Association; and

(ii) In the event of violation thereof the Association shall have the right to evict or pursue any legal remedies and it shall be reimbursed for its reasonable attorney's fees and costs by the owner and/or tenant, and Association shall be entitled to a lien against the said lot for said reasonable attorney's fees and costs as provided in (d) below."

"(d) To be reimbursed by the offending owner for the Association's reasonable attorney's fees and court costs incurred in bringing any action to enforce these covenants and conditions or any violations of the provisions of the governing, documents described in (c) (i) above, and such fees and costs shall be charged to the said owner as a specific item which shall be a lien against the said owner's lot with the same force and effect as it the charge was a part of the annual assessment or any other assessment attributable to such lot owner."
